Since opening the doors to our first warehouse 2½ years ago, Epic-Cure® has rescued and distributed over 8,000,000 pounds of food and provided an average of 64 pounds of food over 124,000 times to families experiencing need or food insecurity.

Dear Friends,

With the help of our volunteers, donors, grantors, and partners, Epic-Cure has successfully faced a challenging 2021. We will get to some of those challenges shortly. We wish first to discuss an important and enduring change made at Epic-Cure[®] in 2021: our management team has been formalized and a Policies and Procedures Manual has been created, ensuring longevity and efficiency in our operations.

Management Practice, Policies, and Procedures:

Our first major accomplishment this year was building our management team. As a 100% volunteer organization, we understood that we must have an infrastructure just like any other company to eliminate key person risk and be sustainable. So, we have built our management team.

Currently, we have 29 volunteers on our management team. It is a dedicated group from diverse backgrounds - engineers, veterans, accountants, salespeople, police officers, nurses, educators, business owners, IT professionals, firefighters, and both high school and college students. And, Epic-Cure has always been fortunate that our patrons also serve as managers. Every one of our managers is consistent, hard working, and completely dedicated to our missions of eliminating food waste and food insecurity, providing cooking classes to engender life skills and self reliance among children and veterans, connecting generations, and raising the dignity of every member of our community.

Improving the management structure is a key objective for 2022. Epic-Cure[®] will grow and build a stronger community by continuously adapting to the changing needs of our patrons and sources of food and household goods.

Building Epic-Cure's® Infrastructure:

Continuing with our accomplishments in 2021, Epic-Cure continued to push forward and build the capacity to rescue more food and serve more people experiencing need. Of the \$118,446 of Net Operating Income in 2021, we invested \$46,836 in capacity-building.

We have completed all the work necessary to open the Palatka warehouse to grocery store style shopping for Epic-Cure's[®] patrons. Currently, we are waiting on the water and wastewater evaluation from the Putnam County Department of Health. Once that has been collected, the USDA and Feeding Northeast Florida will inspect the facility. Assuming we pass those inspections, we will employ a 2-week transition to the grocery shopping model and its happy results: less food waste and greater human dignity.

We also have \$75,000 from a No Kid Hungry grant to purchase, install, and operate an industrial generator to power Epic-Cure's[®] operations from the Palatka facility in times of natural disasters. This capacity is essential, as Epic-Cure is a designated disaster relief agency of Feeding Northeast Florida.

Our 2022 capacity-building goal is to acquire a 3rd refrigerated truck. We have no cushion if either of the reefer trucks that we currently use breaks down. With our leased Ryder truck and with the service contract on our owned truck, Ryder must provide loaner vehicles if the repair will take longer than a day. Ryder does not always have trucks available to lend us in those circumstances. Not only would an additional truck provide the backup we need, but it would also allow us to begin mobile food distributions in Putnam County like the 6 weekly ones we do in St. Johns County using the truck we currently own.

Sustain U.[®] :

Epic-Cure's Sustain U.[®] accomplishments in 2021 are worth noting. The relaunch of cooking classes for children in low-income neighborhoods has exceeded our expectations. Numerous are our volunteers, seniors that fill many of teaching and supporting roles for these classes, and high is the demand for our program among children and their parents. We even have professional chefs teaching classes as permanent and guest mentors.

Our first classes were taught at the Players Championship Boys & Girls Club in the West Augustine neighborhood of St. Augustine, Florida, in October 2021. Classes were conducted for 5 students, ages 11 to 14. The first class emphasized knife skills and included vegetable soup and chocolate-cherry cake (this one, obviously, captured their interest). Since then, the same children have been involved in a total of 14 classes. In December, we added another class site -Woodlawn Terrace Apartments, which is a Section 8 housing complex, also in West Augustine. There are 6 students in that class, and they have worked through four classes so far.

Each class has a teacher, a teacher's helper, and a runner. The three to five ratio of teachers to students reflects our view that highly individualized, hands-on training and the connections between the two generations will foster self-reliance and enhance the well-being of all concerned, including our teaching staff. We hope to create an internship program in local restaurants for those interested students that qualify for it.

We hope to return to cooking classes for veterans. Unfortunately, the COVID-19 pandemic continues to force a pause in those cooking classes.


Further Thoughts on the Mission of Sustain U.[®] :

Epic-Cure's[®] efforts through Sustain U.[®] support the achievement of important goals. While we have stated some of these goals time and again - fostering self-reliance while teach life skills that may even translate into career skills and the connections and relationships formed between divergent generations ("Gen Z" on the one hand and the "Silent Generation and Baby Boomers" on the other) - there is another design worth noting. Through the safe, stable, trusted, and nurturing care of our senior mentors, Sustain U.[®] cooking classes may provide a counterpoint to the damaging stresses that children may confront, particularly those children living in poverty.

Not all stress is bad. Some stress can help in human development. For example, the stress of the "big game" can increase focus and improve performance. Adverse, continuous, and extreme stress may, however, interrupt or retard brain, hormonal, immune, and metabolic development in children, raising their chances for conditions in adulthood like depression, autoimmune disease, asthma, and cardiovascular disease. The medical community is still investigating these links, but we think that relief from childhood stress, particularly in close connection with caring adults, will provide the students of Sustain U.[®] with the resiliency needed to lead happy, healthy, and prosperous lives.

We will buffer adversity to engender resiliency. We will foster self reliance. We will smile as the well being of both our senior mentors and our young students rises. We will extend these program to veterans in need - to return the favor. And, we will endeavor continuously and urgently to accomplish this goal.

Challenges:

Renting our warehouses is one of our most pressing problems. With our booming local economy, warehouse space, which is in short supply, commands a premium price and rising rents. Epic-Cure[®] is not among the most desirable tenants, and we discovered this the hard way this past Autumn when new owners of the Saint Augustine warehouse building which houses our flagship operation and first distribution site informed us that they will not renew our lease when it terminates in March 2022.

Thankfully, we at Epic-Cure are not without friends and resources. A long-time Epic-Cure[®] supporter intervened on our behalf, setting up a meeting with the new owners. We described to them not only the mission but also the impact of our charity in this community. The owners were moved enough to begin a further dialogue with us, and this conversation - along with a guided tour of the flagship Thursday distribution in Saint Augustine led to a new understanding of Epic-Cure and a second chance: the owners have granted us a new lease for one year, and we will use that time to improve our reach, say "Yes" to more people in need, and seek a more permanent solution to the problem of a permanent home for Epic-Cure[®] in Saint Johns County.

There is no guarantee that we will be able to stay beyond the one-year term. We are seeking alternatives, including the possibility of acquiring land and building our own warehouse - a greater possibility than finding an existing facility in this market. In the meantime, our rent has doubled.

To repeat: warehouse space is at a premium, so this is the reality of the new cost of doing business. In Palatka, we see the constant threat of a buyer offering to purchase the building we rent. While we have a 5-year lease with just over 3 years remaining on it, the lease also contains a clause whereby the owner may terminate the lease, with 90-days' written notice, for any reason or no reason at all. So, if the owner finds a compelling offer to buy the Palatka warehouse, then he may exercise that option with but ninety days' notice to us to clear out. As we have much difficult and expensive to move equipment (a 40' by 40' walk-in refrigeration unit; 3 refrigerated sea containers; a forklift; many shelves), the financial blow of losing the Palatka warehouse is one we simply cannot afford.

Challenges (continued):

When we originally signed the Palatka lease back in 2020, we were a new charity with a \$20,000 donation and determination to use that to expand our services to our neighbors in Putnam County, the 4th poorest county in Florida. As you can imagine we had no negotiating power. So, while we do have first right of refusal if another buyer makes an offer, we do not have any capital to purchase the building ourselves. The price we were given a year ago was \$850,000. It is certainly worth more now. Additionally, with the poor condition of the parking lot, were we to purchase the building, any lender would require us to repair the significant deterioration of the parking areas as a condition of a loan. Duval Asphalt has provided an estimate for that repair work: \$148,000.

So, assuming a reasonable increase in the value of the warehouse (between the now roof provided by the owner and the many repairs made by Epic-Cure[®], including the installation of new ceiling tiles, an increase in value is all but certain) to \$1,000,000, Epic-Cure needs about \$1.15 million to purchase the building. We have sought the needed funds from emergency COVID funds (ARPA) and other donors and grantors with no luck so far.

But try we will!

And fail we will not!

A look ahead to 2022...

When it comes to our goals for 2022, let us start where we normally start: with food rescue and distribution. While we are struggling with supply chain issues and reductions in the food available to us for distribution to the food insecure, we maintain aggressive goals for these, our core operations. In 2021, we rescued and distributed an average of 373,396 pounds of food per month. As emergency supplies waned and supply chain disruptions increased, our throughput of food declined to an average of 319,566 pounds of food per month (the half-year from July through December 2021).

- > Our food rescue and distribution goal is 500,000 pounds of food monthly by year-end, 2022.
- > Our "reach goal" is 1,000,000 pounds of food monthly by year-end, 2022.

We expect to reach our goals despite the challenges we currently face: food shortages, supply chain disruptions, a lack of certainty about our bases of operation, and the potential for pandemic related disruptions to the economy and the social fabric of our communities. We will accomplish this fundamental goal as we achieve the following crucial goals related to our infrastructure:

- > Open the Palatka warehouse for grocery-style shopping;
- Acquire a refrigerated box truck to ensure the collection, storage, and transfer of food among the two distribution centers (Palatka and St. Augustine) and the mobile distribution sites that we currently serve;
- > Secure a permanent home for Epic-Cure[®] in St. Augustine, removing uncertainty of the existence or full operations of Epic-Cure[®];
- > Purchase the Palatka distribution facility, again to remove existential and operational uncertainty;
- > Increase our service to other food pantries, particularly from the Palatka distribution center;
- > Build up the number of mobile distributions in Putnam County; and
- > Secure permanent mobile distribution sites in Clay County, Baker County, Bradford County, and Flagler County.

A look ahead to 2022...

We at Epic-Cure[®] also intend to materially increase the scope and reach of our cooking classes, both for middle school aged students at Title 1 schools and for veterans. We currently plan to add 3 new classes in the first quarter of 2022. Adding these classes will bring the total to 5 running at the same time. The classes will comprise approximately 25 school children. We hope to add more classes as we digest the lessons and logistics of simultaneous Sustain U.[®] programs.

Finally, and of no less importance than the other goals we have set, we aim to have our industrial generator installed at the Palatka facility. The importance of this objective cannot be understated. The ability for Epic-Cure[®] to operate in a natural disaster emergency is paramount to the well-being of the communities we serve. Our greatest challenge in the meantime is in getting adequate electrical capacity at the warehouse, which can be achieved by installing three-phase electric (subject to labor shortages) or seeking an upgrade through Florida Power & Light (our preferred method).

We look forward to a fantastic 2022 with our wonderful patrons, our tireless volunteers, and our many sponsors and supporters!

The Problem

Food Insecurity

1 in 6 people in America face hunger

- > Children: more than 1 in 5
- Blacks and Latinos: 1 in 3

Food wasted in the US every year could feed 25 million Americans




In an average month in 2021, Epic-Cure[®] served
